Socio-Economic Aspects of Urban Development

Master of Science in Management, Elective Course
Module Number 07-201-2102

Content of the Module

Cities around the world face challenges as they grow. What are the needs and demands of residents as well as business executives to keep cities thriving, and how can public policy respond? We will be analyzing cities quantitatively, looking at income differences between different part of the city, social segregation and infrastructure connections. The interplay between workers and firms will be discussed in the context of business agglomeration and structural change. With examples from cities around the world, we will examine how climate change affects urban development and how cities can respond the challenges of the future. Combining insights from urban economics, business studies, environmental management, geography and social science, the course aims to provide a holistic picture of important socio-economic issues that cities are tackling.

Goals of the Module

Students will be able to identify socio-economic issues urban development and to compare best practices from around the world. They will be able to calculate and interpret indicators of income inequality, social segregation, business aggregation and urban growth rates, evaluating public policy and drawing critical conclusions. They will work in small groups of 2-3 students for a comparative analysis of two cities using the techniques and insights from the course. They will be able to present their findings in English and defend them argumentatively.

Module Format

Lecture “Socio-Economic Aspects of Urban Development” (2 SWS) = 30 hours of class attendance and 120 hours of independent study= 150 hours

Seminar with practical part “Socio-Economic Aspects of Urban Development” (2 SWS) = 30 hours of class attendance and 120 hours of independent study = 150 hours

Grade

Students work together in small groups (2-3 students) to conduct their comparative analysis of the socioeconomic challenges two big cities face and how they deal with them. The grade for the module is made up of a presentation (30%) and a 15-page written paper (70%).
